1. All clients must be in possession of a current provisional, full or other driving licence entitling them to drive the training vehicle.
2. An eye test will be carried out on your first lesson to ensure you meet the minimum DSA requirement. Please bring with you any glasses or contact lenses you need to meet this requirement. Should you fail the minimum requirements of the eye test the lesson will be cancelled. If you have any doubts about your ability to meet the DSA requirements you should make an appointment with an optician prior to commencing lessons.
3. By signing these terms and conditions you confirms that:
 - You have no physical or other disabilities or impediment affecting your ability to drive.
 - No medication or other treatment is prescribed or being taken which may impair or otherwise affect your ability to drive or that such information has been disclosed to the instructor and to the DVLA. The instructor may require further information to ensure that training may take place.
 - If prior to a lesson, the instructor detects the smell of alcohol, signs of a hangover or other impairment you are advised that, at the discretion of the instructor, the lesson will be cancelled and you will be charged for that lesson.
4. During driving lessons, **mobile phones must be switched off.**
5. In order to be alert, you must have been awake for at least one hour prior to a driving lesson.

Lesson Cancellation..

IF YOU NEED TO CANCEL A LESSON FOR ANY REASON, YOU MUST GIVE 48 HOURS NOTICE OTHERWISE THE LESSON WILL BE CHARGED IN FULL.

Your instructor will do everything possible to ensure that your lessons start and finish on time but reserves the right to cancel, postpone or change lesson lengths and times under certain circumstances (e.g., dangerous weather conditions). In the event of lesson changes by the instructor, lesson fees paid in advance, or an appropriate proportion thereof, will be carried forward with no loss to the pupil.

All lessons will start and finish at the same location unless other arrangements are made with the instructor. If you would like to finish at a different location, your instructor may need extra travelling time to get to the next appointment. If this is the case, the lesson may have to finish early.

PLEASE HAVE PAYMENT READY BEFORE THE LESSON STARTS AS I DO NOT HAVE TIME AT THE END OF A LESSON TO CALL AT A CASH MACHINE. MY NEXT PUPIL WANTS THEIR LESSON ON TIME. THANK YOU.

The Driving Test. In the interests of all pupils, public safety and the safety of driving test examiners, your instructor reserves the right to withhold the use of the driving school vehicle for the test. This action would only be taken if, in the instructor's expert opinion, the pupil's standard of driving on the test day is actually (or potentially) dangerous and therefore not up to driving test standard. Three working days notice (not including weekends and public holidays) is required by the DSA for driving test cancellation. Failure to provide requisite notice of cancellation will result in the forfeit of the test fee. Any outstanding accounts must be settled prior to the practical test.

Responsibility. Your Instructor cannot be held responsible for any postponement or cancellation of tests by the DSA. However, he will do all that is possible to help you to reclaim expenses from the DSA.
